JOB DUTIES and RESPONSIBILITIES:

Assists in all aspects of food preparation and distribution of large quantities of food; cleans, cuts, trims, grinds, chops and/or slices meats, vegetables, fruits and breads; opens containers, bags of frozen vegetables, fruits, dry goods, cereals; when assigned cooks, steams and/or assists cook in cooking vegetables, meat and other food; divides food into delivery meal containers; loads, drives and distributes food and other supplies to various preschool, school, and senior nutrition sites daily; unloads carts upon return; cleans, sanitizes containers and carts, work station and floors; washes tools and equipment; mops and sweeps kitchen; inspects and maintains vehicle for operating condition and safety; checks head lights, brake lights, tail lights, signal lights, mirrors, tires, gas gauge; fuels vehicles as needed; completes and/or ensures that sites complete assigned documentation. Performs other related duties as assigned.
