### **Basic Job Assignment:**

Under the medical oversight of a psychiatrist and administrative supervision of the Charge Nurse, provides comprehensive onsite psychiatric services to a severally mentally ill adult population; and provides professional nursing care to mentally ill patients in a field of specialized competence, which includes health screening, diagnosis, and treatment of mentally ill adults.

### **Employment Requirements:**

The ideal candidate is a self-motivated, team player who possesses a solid knowledge and understanding of: Professional nursing principles, procedures and techniques used in the care and treatment of psychiatric individuals; social, psychological and physical factors of mental and emotional disorders; medical and psychological terminology; state of California laws and regulations for the nursing profession; regulations pertaining to psychiatric nursing and the treatment of the mentally and emotionally disturbed individual, including those with a co-occurring disorder; organization and procedures of rehabilitation and recovery treatment facilities and the use of multi-disciplinary service-delivery teams; symptoms and behavior patterns of severely emotionally disturbed and mentally ill individuals; medical and psychiatric emergency procedures; anatomy, physiology, microbiology, social science, psychology, nutrition and pharmacology; typical and atypical growth and development; norms in laboratory measurements to recognize conditions of clinical significance; identification and management of health problems in a specialized field; community resources and their utilization; common illnesses and health problems; principles of epidemiology; usage of basic medical, laboratory and nursing equipment; historical, social, and legal aspects of nursing; medical ethics; the ability to perform physical and psychosocial assessments; prescribing psychotropic medication; preventing disease and providing health care; developing individual clinical care management plans; assessing the client's immediate needs and ensuring client's receipt of needed services through personal service or making appropriate referrals; exercising appropriate judgment in answering questions and releasing information; analyzing and projecting consequences of decisions and/or recommendations; communicating using tact, objectivity, and confidentiality; demonstrating enthusiasm and motivating clients; is well organized and able to prioritize, plan, prepare, and follow through on assigned tasks in a thorough fashion; has excellent oral and written communication skills and the ability to understand/ carry out oral and written instructions; and has demonstrated experience working with culturally and ethnically diverse, low income or no income families and unique populations.

### **Qualifications:**

- Valid Adult Family Practice Nurse Practitioner Certification/License or Certified Psychiatric Nurse Practitioner in the State of California <u>AND</u> at least two years of full-time registered nursing experience in a psychiatric or other mental health facility; AND
- Valid California Class C Driver's License, which must be maintained throughout employment in this class, is required at time of appointment; or the ability to arrange necessary and timely transportation for field travel;
- CPR and First Aid Certification required;
- Bilingual (English/Spanish) preferred, but not required.

### **Examples of Essential Functions:**

- Prescribe psychotropic and related medications based on clinical indicators of a client's status, including results of diagnostic and lab tests as appropriate to treat symptoms of psychiatric disorders and improve functional health status;
- Administer/monitor the use of and note reactions to psychotropic drugs and other medications and order refills as appropriate;
- Perform timely, accurate, and concise documentation of client care using the Anasazi Electronic Health Record (EHR);
- Collaborate and conduct case conferences with other mental health professionals to identify client care needs, implement approaches, evaluate the effectiveness of approaches;
- Provide crisis intervention and management related to supportive care services;
- Assess clients in crisis situations and facilitate prompt resolution (administering medication, counseling, etc.);
- Consult and collaborate with physicians, nurses, social workers, counselors and other health professionals to assist clients in
  obtaining necessary or requested services (e.g., Medi-Cal, SSI, physical health services, housing, food, etc.) and/or make
  appropriate referrals;
- Coordinate care closely with staff while maintaining a positive, collaborative relationship;
- Participate in shared program operational responsibilities;
- Initiate and continue service plans and ensure that necessary lab tests are completed;
- Work with family members, conservators, etc. to facilitate medication compliance by providing information and instruction;
- Communicate with and/or follow-up with pharmacists and hospitals;
- Perform various administrative functions involved in individual care and program management;
- Update appropriate components of client charts;
- Enter data, obtain and review medical records and prepare program reports.
