#### **Basic Job Assignment:**

Under general supervision of the Project In-Reach Program Director, the Peer Support Specialist provides peer support services to severe mentally ill clients out of San Diego correctional facility settings; serves as a peer coach and advocate and works closely with social workers in providing client-related support services; provides client information that will help current and/or formerly incarcerated individuals regain control over their own life and recovery and rehabilitation process; serves as a role model in recovery and coping skills; and performs related work as required.

#### **Employment Requirements:**

The ideal candidate is a self-motivated, independent worker who possesses a solid knowledge of Social, healthcare, supportive and other services and resources available in the San Diego community for formerly incarcerated individuals; Working with individuals with co-occurring disorders from various socio-economic, cultural and ethnic backgrounds, particularly African-American and Latino populations. The ideal candidate will also have the ability to operate standard office equipment and computer software including Microsoft Office Suite; Work with the incarcerated population and correctional staff; Exercise tact, objectivity, sensitivity, strategy and judgment in dealing with a variety of people with mental health issues; can communicate effectively with staff, managers, clients/ participants, and individuals of varying levels outside of the department and organization; is well organized and is able to plan and prepare in a thorough fashion; practices good personal hygiene; and has demonstrated experience working with culturally and ethnically diverse, low income or no income clients and unique populations.

#### **Qualifications:**

- High School diploma or successful completion of General Educational Development (GED) program required;
- At least one year of related experience and/or training in a setting working with severely mentally ill clients and/or the formerly incarcerated population *required*;
- Lived experience as a formerly incarcerated individual and as a person in recovery from substance abuse, mental health disorder, or both; or as a family member of a formerly incarcerated individual and a person in recovery is preferred.

**Please note:** If in recovery, candidate must demonstrate recovery milestones; substance abuse recovery requires a minimum of three (3) years clean/ sober; if formerly incarcerated, two (2) years off of formal probation <u>and</u> five (5) years since last incarceration date.

#### **Qualifications** (continued):

- Valid TB test *required* upon hire and must be maintained every three years;
- Graduate/Certification from the Recovery Innovations of California (RICA)'s Peer Employment Training Program preferred.

#### **Example of Major Functions:**

- Engages and assists formerly incarcerated individuals to connect with and obtain needed services in the community, such as mental health, employment, and housing services, that suit the individual's needs;
- Engages individuals to utilize Project In-Reach services for determining personal objectives/goals for recovery and steps that need to be taken to achieve these goals;
- Maintains a caseload between 20-25 clients per month;
- Works independent of and in coordination with case management to meet the emotional and practical supportive needs of formerly incarcerated individuals;
- Assists individuals to identify issues that may interfere with the achievement of their goals and helps in the development and use of specific interventions needed for overcoming challenges;
- Teaches individuals how to identify and fight stigma, negative self-talk and other factors that hinder the process of recovery and rehabilitation;
- Assists individuals in making vocational choices, supports their choices and helps them overcome problems related to achieving their goals, including the finding and holding of a job;
- Assists clients in building social skills that will help them re-establish normal roles of life and re-integrate into their communities;
- Teaches and models effective skills for recovery based on personal recovery experience and/ or training;
- Develops and shares recovery oriented materials;
- Informs individuals about community resources and how to utilize these in their recovery;
- Assists individuals in developing empowerment skills through self-advocacy and engagement in a variety of activities that focus on recovery and empowerment;
- Conducts Peer Advisory Groups;
- Collaborates with other service team members on participant concerns; requests assistance and guidance from management and professional staff when necessary to address participant issues and problems;
- Upholds all Program Safety Policies and Procedures and ensures that participants, staff and program facility are safe at all times; maintains a good rapport, respect and communication with law enforcement or court officials, participants and community service agencies.
