Basic Job Assignment:

Under the medical oversight of a psychiatrist, and administrative supervision of the Charge Nurse, the Psychiatric Nurse Practitioner provides comprehensive onsite psychiatric services to a severally mentally ill adult population; provides professional nursing care which includes health screening, diagnosis, assessment and treatment; and management of clients with mental health, substance abuse and co-occurring conditions.

Employment Requirements:

The ideal candidate is a self-motivated, independent worker who possesses knowledge of Professional nursing principles, procedures and techniques used in the care and treatment of psychiatric individuals; Social, psychological and physical factors of mental and emotional disorders; Medical and psychological terminology; State of California laws and regulations for the nursing profession and medical ethics; Regulations pertaining to psychiatric nursing and the treatment of the mentally and emotionally disturbed individual, including those with a co-occurring disorder; Symptoms and behavior patterns of severely emotionally disturbed and mentally ill individuals; Medical and psychiatric emergency procedures; Community resources and their utilization; Principles of epidemiology; Usage of basic medical, laboratory and nursing equipment; and current technology and trends in the profession. The ideal candidate will also have the ability to perform physical and psychosocial assessment; Have the authority to prescribe psychotropic medication; develop individual clinical care management plans; Prepare protocols, guidelines and manuals; Communicate effectively orally and in writing; Establish effective working relationships with physicians, nurses, management staff, other health professionals, employees, and the public; Assess the client's immediate needs and ensure client's receipt of needed services through personal service or appropriate referrals; Exercise appropriate judgment in answering questions and releasing information; Maintain composure in situations which require a high degree of sensitivity, tact and diplomacy; and has demonstrated experience working with culturally and ethnically diverse, low income or no income clients and unique populations.

Qualifications:

- At least two years of full-time registered nursing experience in a psychiatric or other mental health facility; AND
- A valid Adult Family Practice Nurse Practitioner Certification/License or Certified Psychiatric Nurse Practitioner in the State of California is required.
- Current CPR certification is required at time of appointment.
- A valid California Class C Driver's License, which must be maintained throughout employment in this class, is required at time of appointment or the ability to arrange necessary and timely transportation for field travel.
- TB test required upon hire and must be maintained every four years.
- Bilingual (English/Spanish) is preferred, but not required;

Example of Major Functions:

- Assess, diagnose, plan, implement and evaluate nursing care for those receiving mental health services;
- Prescribe psychotropic and related medications based on clinical indicators of a client's status;
- Use results of diagnostic and lab tests as appropriate, to treat symptoms of psychiatric disorders, and improve functional health status;
- Administer/monitor the use of and note reactions to psychotropic drugs and other medications;
- Orders medications and refills as appropriate;
- Perform timely, accurate, and concise documentation of client care using the Cerner Electronic Health Record system;
- Collaborate and conduct case conferences with other mental health professionals to identify client care needs, implement approaches, and evaluate the effectiveness of approaches;
- Provide crisis intervention and management related to supportive care services;
- Assess clients in crisis situations and facilitate prompt resolution (administer medication, counseling, etc.);
- Consult and collaborate with physicians, nurses, social workers, counselors and other health professionals to assist clients in obtaining necessary or requested services (e.g., Medi-Cal, SSI, physical health services, housing, food, etc.) and/or makes appropriate referrals;
- Coordinate care closely with staff while maintaining a positive, collaborative relationship;
- Participate in shared program operational responsibilities;
- Initiate and continue service plans, ensure that necessary lab tests are completed;
- Request assistance and guidance from management and professional staff when necessary to address client issues and problems;
- Work with family members, conservators, etc. to facilitate medication compliance by providing information and instruction;
- Communicate with and/or follow-up with pharmacists and hospitals;
- Perform various administrative functions involved in individual care and program management;
- Update appropriate components of client charts, complete necessary paperwork and enter data and information;
- Obtain and review medical records;
- Prepare program reports;
- Develop mental health diagnostic impressions and provide other primary care services to augment the physician/psychiatrist in defined limited areas;
- Prepare a comprehensive health history of patients, records findings of assessments, and plans for care, follow-up examinations and subsequent evaluations;
- Initiate action within established protocols in ordering and interpreting laboratory tests;
- Advise clients regarding treatment care in assigned field of specialization;
- Serve as a consultant in program planning and development to other nursing and mental health staff in assigned field of specialization.
